General Meeting Minutes - January 2005

- Meeting was called to order at 7:10 p.m. by President Wallace Bow.
- Members decided to head to Charley's at Hoffman Town after the meeting.
- Guest: Several guests introduced themselves and shared which Vettes they own.
- Old Business:
- Wallace reminded members that the Barrett-Jackson event in Phoenix, AZ at the end of January has no remaining accommodations available.
- Super Nationals at Expo New Mexico, 1/28-30; Phil Ellison organizer. The 5 Club entrants are Lori Jordan, Bob DuBois, Derek Larson, Chuck Tipton and Jack Richards. Placards for each vehicle and entry fees will be provided by the Club. Come out and support our Club in this event!
- Phil Ellison showed members 3 mockup samples of placards for Super Nat'ls; members voted on their choice of style. He talked about making available individual placards which could be purchased by members for a fee.
- Governor Ron Scott shared that he had purchased 3 Easy-Up canopies for Club events. He stated that NMCA had reached the 51% NCCC membership for the year 2005. NCCC members have access to \$1 million 3rd party insurance policy. He also reminded everyone that we are part of the Roadrunner Region of NCCC.
- Wallace stated that CASA will be presenting the Club with its' annual support funding this next week.
- New Business:
- Wallace stated that in the past CASA has offered members a deal when purchasing new Corvettes. For 2005 CASA offered to deliver vehicles to members for MSRP (\$10K below sticker price). He also reminded the Club that referrals which result in a purchase from CASA, will net \$200 to the referring person if the buyer mentions that the NMCA member recommended CASA.
- Ron shared that the Nat'l NCCC Meeting will be in St. Louis 2/25-26. He asked members to approve a stipend for his trips to the National NCCC meetings. David Rudd, Club CIA checked the Standing Rules and announced that members will be able to vote on this request at the next General Meeting.
- Ron Scott then asked members if there was any interest in returning to Silverton, CO, to participate in the annual July 4th Parade. If so he will check into discounts at the hotel in Silverton.
- The subject of deposits by members for overnight events was discussed up by VP Jack Richards. The Council is checking into refunding a portion of deposits to members who sign up for an event where the Club secured lodging at a discount based on number and who cannot/do not attend the event. We are trying to eliminate added costs to members and the Club.
- Bill Jackson motioned that members vote on purchase of 2 gas-powered blowers to be used to clear tracks for auto cross events. The motion was seconded and carried. Ron Scott was designated to make these purchases.
- Activities Director Stu Gorelick talked about upcoming 2005 Club activities: Stu shared plans for the upcoming year; caravans, dinner & movie, shows at casinos, drags, overnighters, etc. There will also be golf outings and Lori is checking on logo-shirts for golfing club members. He stated that members should check the website regularly for events dates/times. (www.nmcorvette.org)
- Members were reminded to contact Secretary, Suzanne Monroy (<u>298-1993; MONROYSM@cs.com</u>) whenever there are Club or family members who are ill, hospitalized, or there is a family death.
- February 6 Super Bowl Party to be held at the Logsdon's; 7337 Luella Anne NE. BYO drinks and snacks; subs will be provided by the Club. Please do not arrive before 3 p.m. (kickoff at 4 p.m.)
- Wallace Bow Days begins 2/19 at Sandia MotorSports (\$70 entry fee). First NMCA auto cross scheduled for 3/19 (fee TBA).
- CASA car show (All Chevrolets); 6/05.
- Vettes vs Porsche Challenge scheduled for 7/16; (fee TBA).
- The meeting ended with drawings for prizes. The next Council meeting will be on Tuesday, February 8th at Sandia Computers (all members are welcome to attend). Next General meeting is Friday, February 18th at CASA Chevrolet. The meeting was adjourned by Wallace at 8:05 p.m.
