- The meeting was called to order by Vice President Jack Richards at 6:30 pm. - <u>Activities Director, Larry Osborne</u>, stated that he had completed the activities calendar through July 2006. (check website for updates). He also shared that he has talked with the owners of the storage units @ 98th & Central & he will acquire a unit for the Club & all equipment will be transferred there.
