August 7, 2007

Hugh shared that he was still awaiting the written contract from Rt. 66, but that he had been in contact w/Shelley Bruce of Rt. 66 & everything looks good. Jack also told the Council that this year there will election of new officers for the Roadrunner Region of NCCC.

Vice President, Hugh Monroy, stated that he has asked Chuck Tipton to do the auto teching for SWI along w/himself.

August 17, 2007

The meeting was called to order at 6:55 p.m. by President Shane LeMon. The dinner was from Mario's.

President, Shane LeMon, started the meeting by introducing Wray Ortiz and other members visiting from the Espanola Corvette Club; they now have 35 members (13 cars from this club went to Vettes on the Rockies in Breckenridge, CO last month). Shane mentioned that the Council & several Club members showed up this past Wednesday @ Shane's business to test the timing equipment & learn how to operate the system for SWI. This equipment will be given a dry run @ the autocross on 9/8. Shane will be asking **Activities Director, Jackie Haydu**, to check into the Club participating in the State Fair parade next month.
