PROCEDURES & REGULATIONS

First and foremost, as a member of NMCA you are obligated to act in a manner becoming of NMCA whenever participating in a club event (social or competitive), or when representing NMCA in any official capacity. This includes, but is not limited to, obeying all traffic laws, acting in a courteous manner, and respecting all property, private or public. If there are rulebook challenges or disputes, these issues need to be brought to the attention of the NMCA Governor and event chairperson in a civil, professional manner. When participating in a club organized event, you the member, represent NMCA to other members and to the general public which may be observing or somehow associated with our event. Treat NMCA members and associates with respect and you can expect no less in return.

As we enter a new season of Corvette fun and activities, the time is right to once again review some of the rules and guidelines we must all be aware of. This edition of Tach Times deals with caravans. Subsequent issues will discuss cars shows, high speed events and rallyes. NMCA is an NCCC car club and is obligated to follow the official rulebook as closely as practicable for each event. The rulebook is established to afford a safety factor for all participants while still affording maximum enjoyment. Since NCCC provides an umbrella of insurance protection, we must make all reasonable attempts to conform to the common sense rules set forth.

Caravans:

All cars in the caravan should drive with their headlights on.

If the club has two-way radios, the lead car and the end car <u>should</u> have these to maintain contact. If able, a middle car should also be equipped with a radio.

Left turns across traffic should be kept to a minimum when planning a caravan route.

Chairs need to take all precautions against putting caravan participants in potentially hazardous traffic situations.

All participants (drivers, navigators and/or passengers) <u>must sign</u> an official NCCC waiver before starting the event.

The lead car will be identified to all participants.

You have an obligation to maintain sight of the car behind you.

When traveling in a congested area, stoplights, stop signs, heavy traffic or other circumstances beyond your control, the chairperson and/or lead car <u>should arrange</u> for periodic stops where the caravan may regroup.

There is <u>absolutely no passing</u> of another member unless that member specifically waves you around. Obey <u>all</u> posted traffic signs and laws.

When on the open road, away from city traffic, cars <u>should</u> maintain a minimum of 1 car length for every 10 mph in speed. This is in accordance with all motor vehicle regulations. Corvette owners may wish to increase this distance slightly to minimize any potential of damage due to rocks or other road hazards. A caravan group should be spaced so that non-participating vehicles will not intermix with the caravan. If other vehicles become involved with the caravan procession, use extreme caution if passing so as to rejoin the main caravan group. Your behavior on the road <u>reflects directly</u> upon the group you are associated with.

NEWS FROM SANTA FE

The following was received by NMCA from NMCCC and involves a report of measures and bills involved with the legislature in Santa Fe. This information has not been independently confirmed:

There have been 4 bills introduced this week worthy of note.

SB 844 - Senator Asbill believes that any event recorder in any vehicle should be noted at the time of sale/rental/lease. That way renters and owners would be aware that 'big brother" is watching at all times the vehicle is in use.

SB 824 - Senator Mike Sanchez proposes an absolute maximum speed limit for the state of 55 mph, anywhere, any time.

SB 777 - Senator Rainaldi thinks that the state could make more money on vehicle registration fees if the state charged for and provided (matching) license plates on both ends of the car.

SB 861 - Senator Payne wants each traffic monitoring camera to be duly publicized in advance of the intersection / road where such camera holds jurisdiction.

There will probably be bills introduced before the session is over to address funds derived from traffic cameras to limit the total fine, limit the payout to a third party (who provides the camera or the camera service), and to provide an effective appeal process (aka 'due process' in the bill of rights amendments to the constitution) even though these are civil actions and not government-imposed punishment.
