Review procedures when receiving new members applications.

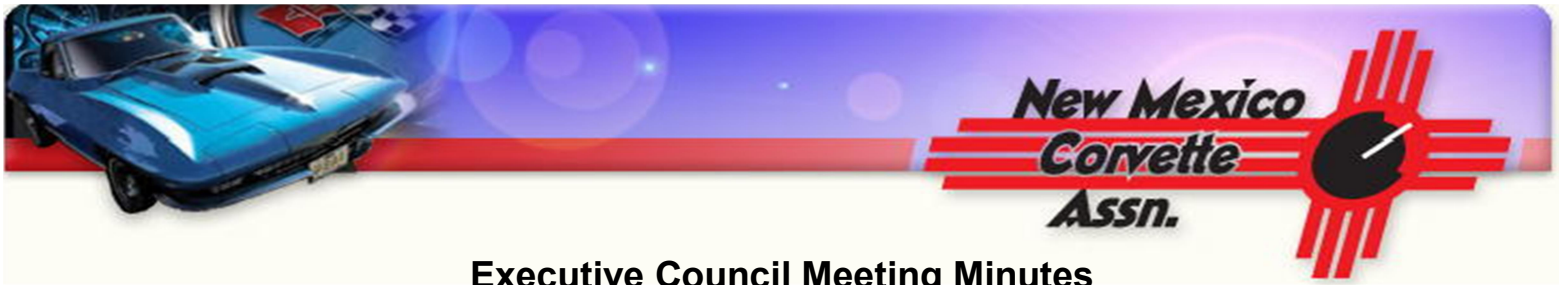
