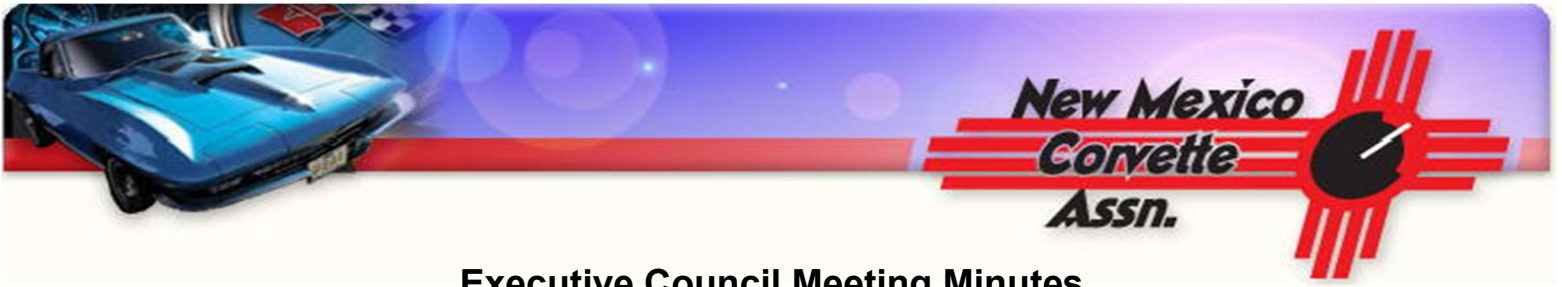

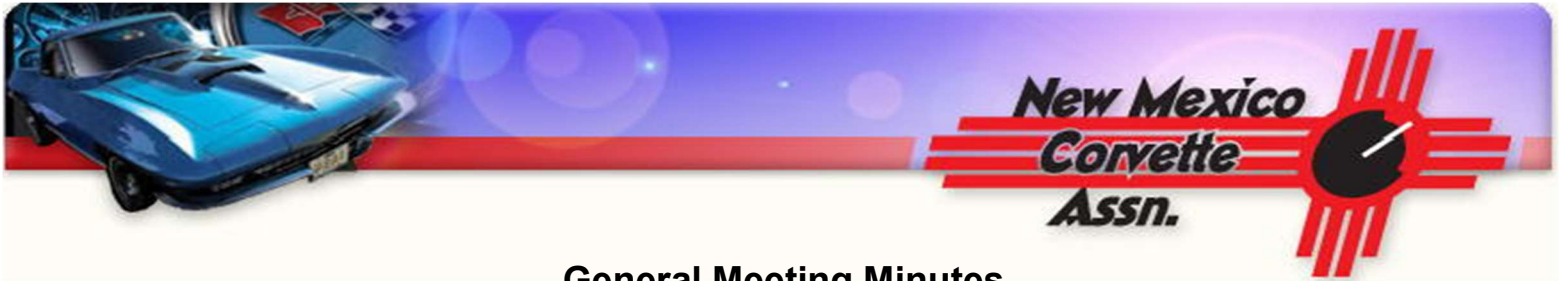

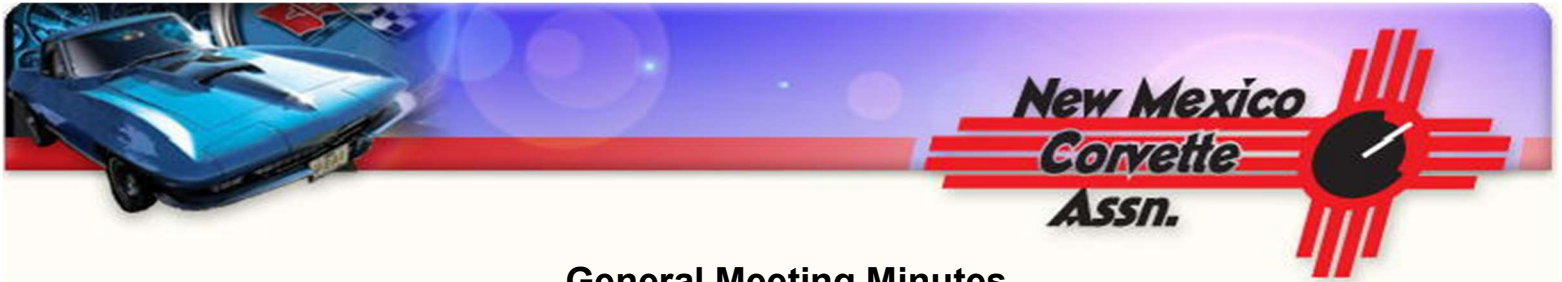
Meeting called to order at 6:30 pm by Rich Mleczko, President

1. Each Officer to give reports (See above for Ron Scott) and see below for others;

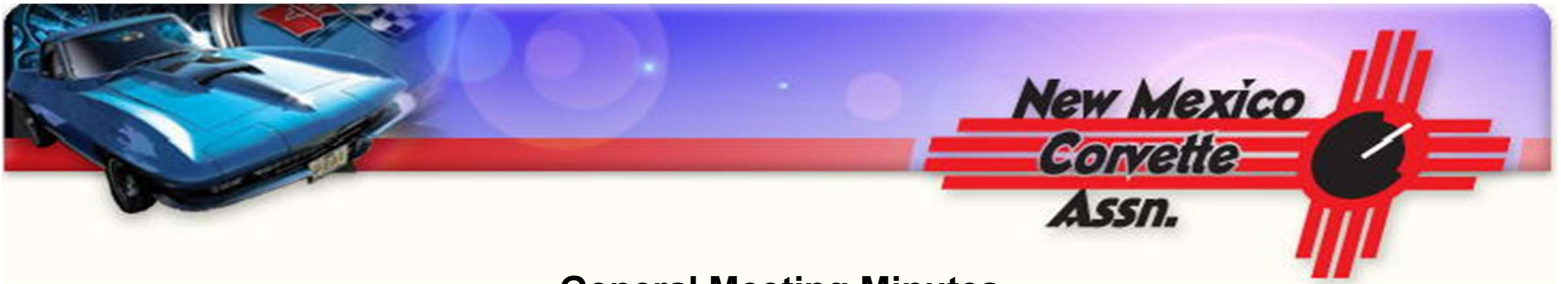
2. Discuss Super National Car Show
